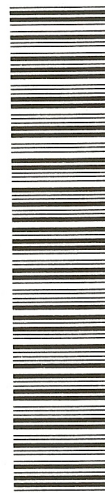

REASON FOR NOTICE

Failure to File FISCAL YEAR 2012 Tax Return

To prevent the issuance of an estimated billing for a delinquent tax period and/or the revocation of your seller's permit, the returns must be filed within ten (10) working days from the date of this notice. Returns filed without payment will be billed for the corresponding tax, interest, and penalty.

If you recently filed a return and submitted taxes due, complete Section I, Verification of Payment, on the back of this notice. If there are any changes to your account information, complete Section II, Account Change. If you are no longer in business, complete Section III, Business Change.

- Late Report Penalty: A 10 percent penalty and interest has been charged for failure to file the return within 60 days of the due date pursuant to Section 1112.5 of the CUIC.
- Wage Item Penalty: A penalty of \$10 plus interest for each unreported employee has been charged for failure to file the quarterly wage report within 15 days after the demand notice pursuant to Section 1114 of the CUIC.
